## 2012 Annual Legislative Conference

The second session of the Eightieth West Virginia Legislature is underway and we must turn our attention to a legislative program which will benefit the state and its working families. Therefore, we are calling a statewide Legislative Conference to convene as follows:

PLACE: Charleston Civic Center, 200 Civic Center Drive, Charleston WV

A general session will convene in West Virginia Rooms 104-105 at 9:00 a.m., on Wednesday, February 1, 2012 to discuss the legislative programs and current status of bills of interest to the membership of the AFL-CIO. Delegates will attend a session of the House and/or Senate in the afternoon and talk with Legislators. Lunch and transportation will be provided.

Plans are being made for a Legislative Reception starting at 6:00 p.m. on Wednesday, February 1<sup>st</sup>. State officials and members of the Legislature will be invited guests.
